PREAMBLE :

The Principal has requested to include the staff appointed to teach the subjects of Commerce and Economics which were introduced during the academic year 1980-81 for the purposes of salary grant. In accordance with the Grant-in-Aid Code, the subjects introduced a fresh become eligible for the purpose of salary grant after the successful completion of (5) five years period from the date of introduction. The Government of Karnataka and Karnataka University has given the affiliation for all the 5 years to both the subjects. The Course/Subject completed five years duration during 1985-86 i.e. with effect from 15-6-1985. After verification of the records the subjects are found to be admissible for the salary grant from the academic year 1985-86 and hence this order.
